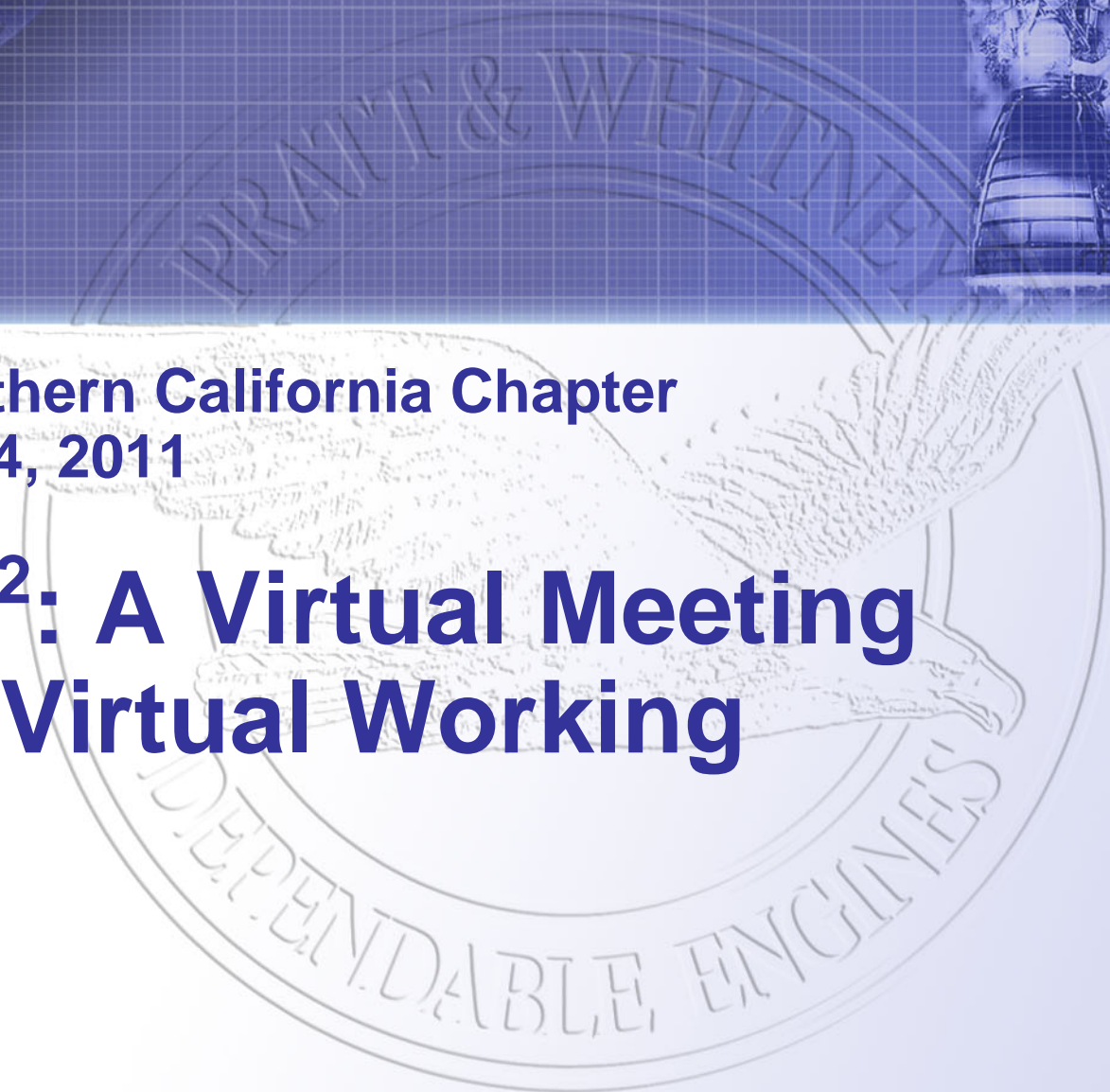

## Major Milestones

- 30 years of successful missions
- Most flown spacecraft ever – 38 missions
- 143 million miles flown...at 17,400 mph
- 362 total days in orbit
- 5,628 trips around Earth
- 246 astronauts/crew members flown
- Launched Hubble Space Telescope
- First shuttle rendezvous with Russian Mir Space Station
- Service missions to International Space Station
- P&W Rocketdyne Space Shuttle Main Engines...3 engines = 37 million HP
